## Commercial Program Customer Frequently Asked Questions

### What are submission deadlines for commercial programs transitioning to the utilities?

Direct Install/Pay for Performance customers will continue to apply to the NJCEP, DI and P4P, existing building programs until the utility’s program launch on July 1, 2021. After July 1, 2021, NJCEP will not accept new DI or P4P, existing building applications. After July 1, 2021, commercial customers will be eligible for utility-run Prescriptive and Custom commercial programs with DI other program offerings starting later in the year.

## **What commercial programs will Atlantic City Electric offer beginning July 1, 2021?**

Atlantic City Electric will offer incentives for Prescriptive and custom measures installed in commercial and industrial properties beginning July 1, 2021. Atlantic City Electric will offer incentives for projects implemented under Direct Install, which is designed to provide comprehensive energy-efficiency solutions to smaller commercial customers, starting August 1, 2021.

## **Will existing discounts or rebates be lower under the new program?**

In general, incentives will remain the same or increase.

## **Can Atlantic City Electric support both gas and electric equipment through the Atlantic City Electric Direct Install Program?**

Yes. New Jersey utilities have developed a system to allow you to work with one of your utilities to simplify the process - apply and receive your incentive from just one of the utilities. The utilities will exchange information behind the scenes to make this as easy as possible for participating customers and contractors.

In general, incentives will remain the same or increase.

## **Do contractors have to complete a Contractor Participation Agreement?**

A participation agreement is not necessary in cases where a customer is pursuing a rebate for a project. However, you will need to complete a Contractor Participation Agreement and submit all required documentation if your customer is interested in accessing Atlantic City Electric's financing options for Prescriptive and custom projects. Participation in the Direct Install program will require a participation agreement. Applications and required information will be posted.

## **If I am working on an existing building project that helps reduce both natural gas and electricity usage, will I have to apply separately to Atlantic City Electric's and my gas utility to access incentives?**

It depends. If you are installing qualifying electric equipment simultaneously with qualifying natural gas equipment through the Prescriptive and Custom Program, you are required to submit separate applications to Atlantic City Electric and the respective gas utility to access the incentives.

You will not be required to submit separate applications for comprehensive projects through Direct Install.

If you submit your application to Atlantic City Electric, we can help serve the entire project provided the customer is served by NJNG, SJG, or PSE&G. The utilities are working collaboratively to develop a system that allows customers to access incentives for both natural gas and electricity saving measures through one utility. Atlantic City Electric and our third-party implementation contractor will handle the entire administration process so you can access the full incentives without extra paperwork.

**Note:** You will be required to provide Atlantic City Electric with the customer's full account number for their gas utility to access incentives.

## **Is there a utility offering to replace the Pay for Performance Program?**

Atlantic City Electric can address comprehensive commercial solutions through our Prescriptive and Custom Program as well as Energy Management Program and Engineered Solutions, which will launch later this year.
